

Wild Spirit Journeys

Baja California Trip: March 23 – 31, 2017

Cost: \$3275/ person, double occupancy

What's included:

- round-trip flight - Los Angeles International Airport to Loreto, Baja California on Alaska /Horizon Airlines
- 9 days, 8 nights
- naturalist-guided boat excursion in Loreto Marine Park
- permits in marine park
- two nights stay in “yurts” at Ignacio Springs
- 22 meals: 10 breakfasts, 5 lunches, 7 dinners
- 3 naturalist-guided whale watching tours at San Ignacio Lagoon
- 3 naturalist-guided sight seeing tours at San Ignacio Lagoon
- all ground transportation
- tips to whale camp guides, camp cooks, all van drivers, boat drivers, naturalists

What's not included:

- air fare from your home city to Los Angeles and back
- airline baggage charges (\$25/bag)
- meals not listed
- optional activities and souvenirs

Notes:

- At the whale camp, showers and bathrooms are separate from the cabins.
- San Ignacio Lagoon is a very remote location. Obtaining medical assistance can take six hours or more.
- **Participants should be in good health and able to walk at least three miles/day.**

Payments:

- Your place on the trip will be confirmed upon receipt of your \$1000 per person deposit along with your Reservation and Personal Information Forms by June 15, 2016.
- Also, we need copies of your passport to submit to Alaska Airlines.
- Second payment of \$1275 per person is due October 15, 2016.
- Final payment of \$1000 per person is due January 15, 2017.

Cancellation Policy:

- Cancellations by September 30, 2016 - \$350 penalty if your place can be filled. Otherwise forfeit the original deposit.
- Cancellations after September 30, 2016 - \$650 penalty if your place can be filled. Otherwise forfeit all payments.
